Fire Chief's Report

March 10, 2020

Department Update(s)

- We are in the application process to fill the three SAFER grant funded firefighter positions.
- I would like under presentations, to discuss the parcel tax assessment we had the study on previously. Specifically, what it would look like to move forward with possibly putting it on the November General election ballot.
- Annual Appointment to the LAFCO Board. Currently Chairperson Clarke is our appointee.
- Currently re-writing the job description for the Battalion Chief/ Fire Marshal position and looking at the possibility of just filling a fire inspectors' position.
- The staff has again started the process to begin the impact fee study and service fee schedule for the department. Along with this, we have met with City Staff to renew our services agreement contract for them collecting our fees.
- Continue to work on updating the policy and procedure manual.
- The female who caused the damage to the station has denied the plea offer and the case will be going to jury trial in the coming months.
- One action item to make ladder truck payment and second action item to reimburse our general fund from the Mello ROOS CFD account for the work performed last year on the vegetation management project at Pleasant Hills.
- We received \$2,500 from the Shasta Regional Community Fund grant to purchase new hose and nozzles. This order has been placed and we expect to accept delivery any day.

- We received \$2,500 from Clean Rite Build Rite from their benefit golf tournament and the money is being used to purchase ballistic armor for the engine crew for active shooter/ mass violence incidents. Meeting sales reps to find the best quality armor to fit our needs.
- Received \$2,000 from Anderson Explodes for the replacement of the station flagpole. The money was originally slated to be given to the Anderson Cemetery. Due to unfortunate events, those plans fell through and they decided to gift the money raised from the Memorial Day pancake breakfast to AFD.

Investigations

- Fire at the train bridge on Barney Street. Suspect in this case accepted the plea offer from the DA and we are now awaiting sentencing. DA's office did a nice press release giving us credit in this case.
- Follow-up on open cases as time allows.
- The preliminary hearing for the Cottonwood arson case has been changed to March 24, 2020.

Meetings/Significant Events

- Meeting with our cooperators to establish countywide protocols on how we will
 respond to an active shooter/mass violence incident. We are having a county wide
 drill on April 18.
- AFD along with APD will be hosting two training days in March to get both agencies working together ahead of the County wide drill and to continue to pre-plan for incidents that may occur in Anderson.


